

United Way of Mesa County's Community Impact Fund Grant Eligibility Requirements and Grant-Making Process

United Way of Mesa County will accept applications for the 2026 FY grant cycle **January 5 to February 12, 2026**. Allocation volunteers will be trained in February and meet in March and April to review and make decisions on grant applications. UWMC will start setting up site visits in February and March and hold site visits virtually in March and April. The United Way of Mesa County Board will make final decisions at their board meeting in May and agencies will be informed of decisions in May 2026. Payment of grants are made quarterly beginning July 1, 2026.

Standards for Eligibility

An agency is eligible to apply for United Way of Mesa County program funding if the agency meets the following standards:

Legal Status

The applicant agency must have a 501(c)(3) classification with the Internal Revenue Service, and have been incorporated for at least two years, as of January 1 of the application year. The applicant agency must also be in good standing.

Policy of Non-Discrimination

The applicant agency must have adopted a policy of non-discrimination that is in compliance with all state and federal laws, and applicable to persons served, staff employment and membership on its governing board.

Board of Directors

The applicant agency must have a local Board of Directors or Advisory Board/Council, which governs the affairs of the organization, meeting at least four times a year, keeping minutes of its meetings. The Board/Council must include volunteers who represent a cross-section of Mesa County residents.

Bylaws

The applicant agency must have written bylaws which accurately describe the agency structure, mission and operations.

Financial Status and Accountability

The applicant agency must be financially viable, have a charitable support record, and willingly account for all financial operations, including provision of an independent annual audit, review, or compilation conforming to Generally Accepted Auditing Principles (GAAP). We will also accept a 990 form if the agency is too small for an audit.

Agency Program and Mission

The agency program and mission must provide direct health and human services within Mesa County. The agency must have at least one staff person, salaried or unsalaried, assigned at least half time, to conduct and/or administer the activities of the organization.

Funding Agreement

If funded, the agency will sign and abide by the terms of the United Way of Mesa County funding agreement, which links funding to measurable objectives and requires semi-annual reporting on completion of those objectives.

For this purpose, "primarily religious" services are ones which promote or support a specific religion or religious cause, or ones which require as a condition of receiving service that a person belong to or actively participate in a specific religion or religious cause. "Primarily political" services are ones which promote or support a partisan political organization or position or advocate for special interest groups. "Formal education" includes formal instructional programs conducted by faculty members of academic institutions but excludes structured activities which may be conducted in school classrooms by others.
